

**V3TechServ Business Partner of HPE** and will identify a single individual each who will act as the representative respectively with regard to entire coordination of the education delivery.



#### 4) Campus Drives:


- Campus Drive defined as 10 participating companies (each dept 3 companies except civil dept).

The MOU will be for a period of One year effective from 11.10.2022.


